## 3A MINUTES FROM PREVIOUS MEETING

## 4. REPORTS AND OVERVIEW OF ACTIVITIES

## 4.1 From Project Management

IC provided the meeting with an overview of operations of the CHPP. IC advised cladding works will be undertaken at the completion of commissioning – late 2004. 400 tonne per hour currently operating at. Mining operations progressing – May 2005 finish mining of box cut and eastern emplacement completed. Rehabilitation works will continue on overburden emplacement.

#### 4.2 From Environmental Officer

CD spoke about the quarterly air quality dust report. Report provides results from air quality monitors on site. CD took the committee members through the report – explaining the data. The CCC members requested a map showing dust monitor locations.

#### 4.4 ACTION ITEMS FROM PREVIOUS MEETING

Items were discussed and the outstanding issue of road safety along Glennies Creek Road was added to the action items from this meeting.

#### 5. MODIFICATION TO DEVELOPMENT CONSENT

IC advised he had done door knocking around the Village with regard to the variation to the development consent to raise the height of the emplacement. IC advised a Community Meeting will be held on 8 September 2004 at the Camberwell Community Hall.

Peter Barton (ACOL's Technical Manager) addressed the meeting on the variation to the Development Consent. JM raised the question of savings to ACOL ie. no construction of dams, no hauling costs, etc. JM also raised the possibility of the western emplacement sterilising open cut reserves.

#### 6. GENERAL BUSINESS

DO raised the issue of noise coming from the Mine. JM raised issue of hearing noise from washery. JJ will look into beepers on HWE plant. DO raised issue of nitrous oxide from blast on Saturday 28.08.04 – JJ said no harmful impact on community.

DO raised issue of blast observation sheet. CD said a meeting will be scheduled to discuss the results. MM suggested the more people in the village to fill in the blast observation sheets the better to get a better result. DO said blasting earlier in the day is providing a better result than blasting later in the day.

Rain diverters – inline filters system – will ACOL issue replacement cartridges? ACOL advised they will not be installing inline filters – only rain diverters will be supplied except in circumstances where they are not compatible with existing plumbing.

CCC agreed to keep meeting day on a Tuesday. IC advised ACOL will re-imburse residents on phone calls made to the Environmental Hotline number.
