#### 6. REPORTS AND OVERVIEW OF ACTIVITES

#### 6.1 ASHTON STATISTICS

WF and JB provided a summary of the statistics since the last CCC meeting. This included community donations, production, complaints, incidents and safety statistics. Production was slightly behind budget and one complaint was received and investigated.

# 6.3 OVERVIEW OF OPERATIONS / PROJECTS / EXPLORATION

WF updated the CCC on production progress of the mine. ACOL has recently commenced extraction of Longwall 106A with development progressing in the Upper Lower Liddell (ULLD) seam.

WF provided an update on the SEOC project. There has been no movement with this project since the previous meeting.

JB advised that there had been no surface exploration conducted on EL5860 or EL4918 in the period since the previous CCC meeting.

#### 6.4 APPROVALS UPDATE

JB gave an update on the approvals determined since the previous meeting including:

- DA Mod 5 CCC implications
  - Discussion regarding the implications for the CCC of DA Modification 5 which includes:
    - Appointment of an independent chair
    - Payment of CCC members
    - Provision of additional information
    - Current members may continue their representation



- It was noted by GA that the DA is inconsistent with the Department of Planning and Environment CCC Guideline document.
- Environment Protection Licence Variation
  - Amendments to the air quality monitoring program proposed by the EPA which involve the consolidation of the monitoring network recognising the success of the Upper Hunter Air Quality Monitoring Network
  - ACOL has amended the Air Quality Management Plan to align with the revised EPL
- DS gave an update on a potential SEOC Administrative Modification which involves imposing a condition that requires Ashton to formally notify the Secretary (Department of Planning and Environment) of its intention to commence development development could only commence when the Secretary agreed that Ashton had met all its obligations under the SEOC Approval (such as satisfying condition 10A with respect to property 129) preparing management plans, etc. This modification would defer requiring fulfilment of any obligation under the conditions of approval until such time that Ashton chose to "take up" the approval
- JB provided an update on the Ausgrid Asset Management Plan (AMP) for LW106. This AMP was approved to extract under the Ausgrid power lines overlying LW106. Significant upgrades of the power poles was undertaken to ensure that they were tolerant of predicted subsidence movements.
- JB advised that the LW201-204 Extraction Plan Application was lodged on 8 November 2016.

#### 6.5 ENVIRONMENT MONITORING

# **Dust Monitoring**

JB provided an overview of the dust monitoring sites and results for depositional dust gauges, High Volume Air Samplers and real time TEOM PM<sub>10</sub> monitors, showing the Rolling Readings since the previous CCC meeting. Of note was the slightly elevated annual rainfall and a recent declining trend in total suspended dust measured through the site HVAS air quality monitoring network.

## **Water Monitoring**

JB presented the surface and groundwater monitoring results. No unusual monitoring results were detected at any site.

### **Noise Monitoring**

Attended monthly noise monitoring did not detect any exceedances since the last CCC meeting.

#### **Other Matters**



JB gave an update on the Upper Hunter Mining Dialogue and invited all members of the CCC to attend the Stakeholder Annual Forum.

DS gave an update on the status of residential properties in Camberwell with all properties tenanted and an audit of electrical wiring completed at all homes.

DS gave an update on the H2 2016 Community Support Program including the recent partnership between Yancoal and the Clontarf Foundation.

DS presented on the Bowmans Creek Diversion which won the 2016 NSW Minerals Council Environmental Excellence award.
